

THE COPLESTONS OF CREWKERNE AND OFFWELL

The Will of Agnes Chichester of Curry Mallet, d/12 Sept 1545, proved 7 Nov 1548 left the residual estate to her Executors, John Copleston and Margery his wife. The survey of Chantry Lands belonging to the free Chapel of St. James in Curry Mallet states that John Copleston held both the Chapel and 53 acres of lands for a rent of 46s6d in 1548.
