Christopher Coplestone of Kingdon in Alverdiscott, in com. Devon, bap. 27 Oct. 1564 at Bideford, named in his father's will, bur. 21 Oct. 1637 at Bideford. Will 20 Oct., pro. 9 Nov. 1637 Archd. Ct. Barnstaple. Admon. "de bonis non" granted 1 Mar. 1661-2 to Margaret Copleston, widow of his son Thomas. Act Bk. P.C.C.
 Mary, Da. of John Addington of Bidiford, mar. 10 Dec. 1593 at Bideford, extrix. of the will of her husband, bur. 21 Apl. 1640 at Bideford. Will 26 Oct. 1638. Admon. "de bonis non" granted 1 Mar. 1661-2 to Margaret, the widow of her son Thomas. Archd. Ct. of Barnstaple.
 Mary, 1 da., Francis, 2 da., Grace, 3 da., named in her father's will, living 1569, mar. to ... Bevil of North Lew.
 Francis, 2 da., named in her father's will, living 1569, mar. to ... Taylor.
 Grace, 3 da., named in her father's will, living 1569, ux. ... Vigors.

George Coplestone, 3 son, bap. 7 Apl. 1605, Bideford.

Christopher Copleston, fil. et hæres, bap. 11 Aug. 1594 at Bideford, et. 26, 1620, named in the wills of his father and mother, bur. 29 June 1650 at St. Margarets, Westminster. Admon. granted 12 July 1650 to Catherine the relict. Act Book P.C.C.

Katherin, Da. of .. Dennis of Gloucestershire, son & key. of Sir. Moris Denis. Adm. to her husband.

Thomas Coplestone of Eastwood near Bideford, 4 son, bap. 21 Dec. 1607 at Bideford, 3 surviving son, et. 12, 1620, named in the will of his father and extr. of his mother's will, d. 13 bur. 14 July 1656 at Bideford. Admon. granted 21 Nov. 1656 to Margaret his widow. Act Book P.C.C.

Margaret, da. of .., Adm. to the estate of her husband, also of her father and mother in law not Adm. by Mary the relict nor by her husb. Thomas the extr. of his mother's will, bur. 16 Nov. 1669 at Bideford.

Letitia, da. of William Hungerford of Little Bedwin, co. Wilts, bur. 1 Dec. 1642 at Alverdiscott.

Launcelot Coplestone, 2 filius, bap. 28 Apl. 1597 at Bideford, et. 21, 1620, named in the wills of his father and mother, living 1638.

William, Catherine, 2 wife. fil. unica, ob. unmar.

Thomas Coplestone, bap. 21 Dec. 1634 at Bideford, named in the will of his grandmother, bur. 6 July 1680 at Bideford.

Susannah, da. of .., remar. 17 Mar. 1684-5 at Horwood to William Wadland of Bideford.

Mary, bap. 14 March 1639 at Bideford, mar. 4 June 1663 at Frithelstock to William Mill.

Mary, bap. 27 June 1639 at Bideford. Elizabeth, bap. 3 May 1642 at Bideford, mar. Gustavus Adolphus Mell of Ramsbury, co. Wilts.

Christopher Coplestone, of St. Sepulchres, London, died at Hogsdon, 1 May 1700, aged about 70.
